

Notice of Amendment to the Terms and Conditions of "Dah Sing Visa Infinite Credit Card" Offer

With effect from the respective effective date as stated below, certain terms and conditions of [Section III 'Terms and Conditions of "Quarterly Reward Offer"'](#) and [Section IV "Terms and Conditions of Priority Pass Airport Lounges"](#) under the 'Terms and Conditions of "Dah Sing Visa Infinite Credit Card" Offer' ("**T&C**") of Dah Sing Bank, Limited (**the "Bank"**) shall be amended as follows:

1. Terms and Conditions of "Quarterly Reward Offer"

In light of the cessation of "Quarterly Reward Offer" on 31 Dec 2024, with effect from 1 Jan 2025, Section III 'Terms and Conditions of "Quarterly Reward Offer"' of the T&C with all the clauses thereunder will be deleted in its entirety, and the subsequent sections of the T&C thereof will be renumbered in sequence order accordingly.

2. Terms and Conditions of Priority Pass Airport Lounges

With effect from 1 Feb 2025, the Priority Pass Airport Lounges Privilege will be amended and the major amendments are as follows:

- Promotion period will be added.
- The number of complimentary access to Priority Pass Airport Lounges for the principal cardholder of Dah Sing Visa Infinite Credit Card who fulfills designated spending requirement will be changed from a maximum of 4 times to a maximum of 2 times. Also, "Eligible Spending" will be amended and renamed as "Lounge Privilege Eligible Spending".
- The access fee will be changed from HKD210 to HKD250 per person per visit.
- Dah Sing Visa Infinite Credit Card cardholder can visit dahsing.com/card/vipl/en for the guideline of the use of Priority Pass Airport Lounges (including the requirements for the use of Priority Pass membership card).

As a result of the abovementioned updates, the clauses under Section IV "Terms and Conditions of Priority Pass Airport Lounges" of the T&C will be deleted and replaced by the following:

1	The promotion period of the Priority Pass Airport Lounges Promotion is from 1 Feb 2025 to 31 Dec 2025 (both dates inclusive) (" Promotion Period ").										
2	For the guideline of the use of Priority Pass Airport Lounges (" Lounges "), please refer to dahsing.com/card/vipl/en .										
3	<p><u>Principal cardholders of Dah Sing Visa Infinite Credit Card are entitled to 1 complimentary access pass to the Lounges per quarter^ if they have fulfilled the Lounge Privilege Eligible Spending[#] of HKD50,000 or above* in the preceding quarter, subject to a maximum of 1 complimentary access pass within each quarter and a maximum of 2 complimentary access passes within the Promotion Period.</u> The complimentary access passes cannot be carried forward to subsequent quarters and shall automatically expire at the end of the quarter in which they are issued. If the Lounge Privilege Eligible Spending threshold is not reached or 2 complimentary access passes have already been used within the Promotion Period, the Bank will levy an access fee of HKD250 per person per visit on the Principal Card cardholder's account. Please note that you may refuse to accept the above amendments by giving notice to the Bank to terminate the relevant Dah Sing Visa Infinite Credit Card. Otherwise, the above amendments shall be binding on you if you continue to maintain and / or use your Dah Sing Visa Infinite Credit Card and / or use the relevant services of the Bank on or after the effective dates mentioned above. Please also note that the Bank may not be able to continue to provide you with the services in relation to the Dah Sing Visa Infinite Credit Card if you do not accept the above amendments.
