- 1. 推廣期由 2018 年 7 月 3 日起至 2018 年 12 月 31 日 (包括首尾兩天) (「推廣期」)。

- 3. The Bank's Existing Customer refers to any existing personal customer of the Bank who has any deposit account maintained with the Bank and is aged 18 or above.

- Successfully opens the first 328 Business Account (including both Current Account and Savings Account)
 during the Promotion Period and did not maintain any account with the Bank within 1 month prior to the account
 opening; and
- ii. A daily average "Total Relationship Value" ("TRV") of HK\$10,000 or above (or its equivalent) throughout the calendar month after the month of account opening (please refer to Clause 5 of these Terms and Conditions for the definition of "TRV"); and

- iv. Such 328 Business Account must be maintained with a valid status at the time when the Referral Rewards are credited.
- 5. The calculation of TRV herein includes the New Company Customer's deposit balance of deposit accounts, latest market value of investment accounts, loan outstanding of loan accounts, and mortgage loan accounts, and total cash value of insurance policies enrolled in at the Bank's branches. The daily average TRV will be calculated by the Bank on the last business day of that calendar month. For details, please contact the Bank's staff.
- 6. Both the Existing Customer and the New Company Customer, in each case, are required to complete this referral form to join the referral program. Only one Existing Customer (i.e. the Existing Customer whose referral form is first recorded by the Bank) will be entitled to the Referral Reward once only for each successful referral of each New Company Customer.
- 7. The respective Referral Reward will be credited to the Existing Customer's deposit account which is named in the Referral Form within 2 months after the New Company Customer has fulfilled the respective criteria. The Existing Customer must maintain such valid deposit account at the time when the Referral Rewards are credited.
- 8. The purpose for the customer information collected (include customer name, company name, contact number and the account number) in the Referral Form will be used to make contact and verify the identity of the Existing Customer and New Company Customer, and fulfilment of the Referral Rewards. Any customer information which is collected through this Referral Program will be destroyed within 1 year of the completion of the internal assessment after the Promotion Period.
- 9. This referral program is not applicable to branch, sales and customer service staff of the Bank.
- 10. In the case of any discrepancy between English and Chinese versions, the English version shall prevail.
